2012 SCHOLARSHIP APPLICATION GUIDELINES



Application Deadline March 17th, 2012

The Denton County A&M club is pleased to accept your application for the 2012 Scholarship Award. Below you will find pertinent guidelines for submitting your application to the Scholarship Committee. Be sure to read the information carefully and fill out the application as completely as possible. The Denton County A&M Club offers this scholarship without regard to race, religious preference, gender or ethnic origin. All information contained in your application will be held in the strictest confidence by the Scholarship Committee except as noted for the promotion of the scholarship program.

The 2012 Denton County A&M Club Scholarship Award is for a total of \$1000. The scholarship recipient must be a full-time student at Texas A&M University at College Station in the fall semester after their Senior year in high school.

ELIGIBILITY REQUIREMENTS: The recipient must be a resident of Denton County and be a graduate of a Denton County High School or must be a member of the immediate family of a Denton County A&M Club Member.

QUALIFYING APPLICATIONS: For an application to be considered by the Scholarship Committee, it must include a completed application form, an official high school transcript and an official copy of your SAT scores. Please PRINT or type all information in a legible format.

ADDITIONAL INFORMATION: You may include additional attachments to the application should you need more space to explain your answers. You may include letters of reference or letters of recommendation from teachers, counselors, employers or others if you desire.

UNIVERSITY ADMISSION STATUS: The successful applicant must be accepted to Texas A&M University and the scholarship moneys will be used only for enrollment at Texas A&M University. Funds are sent to A&M and credited to the recipient's account.

SELECTION PROCESS: After all Applications are received on March 17th, selection of the scholarship recipient is a two-step process. First, an initial screening of all applications will be made with five to ten applicants selected for an interview. The initial screening will be completed in late March, and the finalists will be contacted for an interview. Second, the personal interviews with the Scholarship Committee will be conducted between the late March/early April. The scholarship recipient will be notified in mid-April and formal presentation will be made at the Aggie Muster and High School Awards Ceremony on April 21st.
